WARNING ASSUMPTION OF RISK, RELEASE OF LIABILITY AND INDEMNIFICATION AGREEMENT.

PLEASE READ CAREFULLY BEFORE SIGNING.

THIS IS A RELEASE OF LIABILITY AND WAIVER OF CERTAIN LEGAL RIGHTS.

The person who is assisting with, taking part in, attending, or competing in the Nekton Surf Shop summer slide Skimboard Contest shall be referred to hereinafter as "PARTICIPANT." "THE UNDERSIGNED" means only the PARTICIPANT, when the PARTICIPANT is 18 or older **OR** it means both the PARTICIPANT and the PARTICIPANT's parent or legal guardian when assisting with, and preparing for the Nekton Surf Shop summer slide Skimboard Contest as well as taking part in the Nekton Surf Shop summer slide Skimboard Contest, competing in the Nekton Surf Shop summer slide Skimboard Contest, skimboarding and swimming in general (hereinafter the "EVENT") can be **HAZARDOUS AND INVOLVES THE RISK OF PHYSICAL INJURY OR DEATH.**

THE UNDERSIGNED agree and understand that there are risks associated with strenuous physical exertion and with participating in the EVENT and that **INJURIES AND/OR DEATH** may result from engaging, participating, practicing for, and competing in the EVENT. THE UNDERSIGNED agree and understand that risks include, but are not limited to: head, neck, and back injuries, broken bones, drowning, shark and other animal attacks, and other physical injuries common to skimboarding as well as varying weather and visibility conditions, hidden or visible obstacles, broken glass, rocks, as well as the physical conditions of the PARTICIPANT, dehydration and collision with other participants. In consideration of allowing the PARTICIPANT to participate in the EVENT, The UNDERSIGNED hereby agree to **ASSUME ALL RISKS** associated with the PARTICIPANT's participation in the EVENT. Additionally, THE UNDERSIGNED agreed to **HOLD HARMLESS, RELEASE, DEFEND, AND INDEMNIFY** Lopez Boarding company LLC, Nekton surf shop, their affiliated organizations and companies, their insurance carriers, each of their respective agents, employess, representatives, assignees, officers, directors, and shareholders (each hereinafter a "RELEASED PARTY") **for ANY AND ALL LIABILITY** and/or claims for injury or death to persons or damage to property arising from the PARTICIPANTS's participation in the EVENT. **Including those claims based on any RELEASED PARTY's alleged or acrual NEGLIGENCE OR BREACH OF any express or implied WARRANTY.**

THE UNDERSIGNED take full responsibility for any injury or loss to Participant, including death, which PARTICIPANT may suffer, arising in whole or in part out of the EVENT. By signing this release, THE UNDERSIGNED **AGREE NOT TO SUE** any RELEASED PARTY and agree they are **releasing any right to make a claim or file a lawsuit against any Released Party.** The UNDERSIGNED further **AGREE TO DEFENT AND IDEMNIFY** each RELEASED PARTY for any and all claims of The UNDERSIGNED and/or a THIRD PARTY arising in while or in part from the PARTICIPANT's participation in the EVENT. The UNDERSIGNED agree to pay all costs and attorneys' fees incurred by any RELEASED PARTY in defending a claim or suit brought by or on behalf of THE UNDERSIGNED.

THE UNDERSIGNED represent that the PARTICIPANT is in good health and there are no special problems associated with his/her care. THE UNDERSIGNED represent that they have or will inspect the contest and surrounding area prior practicing for or participating in the EVENT. THE UNDERSIGNED authorize any RELEASED PARTY and/or their authorized personnel to call for medical care for the PARTICIPANT or to transport the PARTICIPANT to a medical facility or hospital if, in the opinion of such personnel, medical attention is needed. THE UNDERSIGNED agree that upon PARTICIPANT's transport to any such medical facility or hospital that the RELEASED PARTY shall not have any further responsibility for PARTICIPANT. Further, THE UNDERSIGNED **agree to pay all costs** associated with such medical care and related transportation provided for PARTICIPANT and **shall indemnify and hold harmless the RELEASED PARTY from any costs incurred therein, or any claims originating there from.**

In consideration for allowing the PARTICIPANT to participate in the EVENT THE UNDERSIGNED agree that **ANY AND ALL CLAIMS** for injury and/or death arising from the PARTICIPANT's participation in the EVENT shall be **GOVERNED BY FLORIDA LAW.**

In the case of a minor PARTICIPANT, the undersigned parent or legal guardian consents to PARTICIPANT's participation in the EVENT and acknowledges that he/she is also signing this release on behalf of the minor PARTICIPANT and that minor PARTICIPANT shall be bound by all the terms of this release. Additionally, **by signing this release as the parent or legal guardian of a minor PARTICIPANT, the parent or legal guardian understands that he/she is waiving certain rights on behalf of the minor that the minor otherwise may have.** The Undersigned parent or legal guardian agrees that but for the foregoing, the minor would not be permitted to participate in the EVENT.

By signing this release without a parent or guardian's signature, the PARTICIPANT represents that he/she is at least 18

years of age, or, by signing as the parent or guardian of the PARTICIPANT, you represent that you are the **legal** parent or guardian of the minor PARTICIPANT.

This release shall be binding to the fullest extent permitted by law. If any part of this release is deemed to be unenforceable, the remaining terms shall be an enforceable contract between the parties. This release shall be binding upon the assignees, subrogors, distributors, heirs, next of kin, executors and personal representatives of THE UNDERSIGNED.
